## ANNOUNCEMENT FROM WATER AUTHORITY OF JORDAN-WAJ INVITATION TO TENDER

Under the German Financial Cooperation with Jordan, Kreditanstalt für Wiederaufbau (KfW) has provided finance for the WRMP Water Resource Management Programme. The amounts of the loans for the WRMP cover 80% of the total cost of the programme and the remaining 20% provided by the water Authority of Jordan. WAJ has allocated apportion of these funds for the works described in this tender.

- The scope of work comprises:
  - Supply and install HDPE Pipeline of Diameter 63 mm of about 37 km length.
  - Supply and installation of house connections, including HDPE pipes of diameters 32mm, 25mm of about 7 km length.
  - Relocation of customer meters, including installation of new galvanized steel pipes of about 7.5 km length inside the border of a number of plots.
  - Disconnections of 2", 1", 1/2", 3/4" and reconnections to the existing supply networks.
  - Supply and installation of valves, fittings ...etc.
- The Ministry of Water and Irrigation / Water Authority of Jordan through the Performance Management Unit, Special Tendering Committee for Water Resources Management Program requests eligible **International Contractors specialized in water and sewerage and Local Contractors registered with the Ministry of Public Works and Housing, limited to First or Second grade classified in water and sewerage work**, are allowed to tender the **for "Rehabilitation of House Connections in Irbid, Jarash and Ajloun Governorates"**.
