**PROCUREMENT OF THE PRODUCTS AND INCIDENTAL SERVICES UNDER
JAPAN'S GRANT AID
THE PROJECT FOR ENERGY CONSERVATION THROUGH UPGRADING
WATER SUPPLY NETWORK
BY THE GOVERNMENT OF THE HASHEMITE KINGDOM OF JORDAN**

The Government of the Hashemite Kingdom of Jordan (the Recipient) has received a grant of one billion one hundred and thirty-two million Japanese Yen (JPY1,132,000,000) from the Government of Japan to purchase the products and incidental services to such products for contributing to the Project for Energy Conservation through Upgrading Water Supply Network by the Hashemite Kingdom of Jordan (the Programme). Utilizing part of the Grant, the Tender will be carried out for procurement of "Sluice Gate Valve and Air Valve".

Japan International Cooperation System (JICS) acts as a procurement agent for and on behalf of the Recipient in accordance with the Exchange of Notes signed between both Governments and Grant Agreement signed between the Government of the Recipient and the Japan International Cooperation Agency (JICA).

The products and services to be procured for the Programme include, but not limited to:

- a) Sluice Gate Valve
- b) Air Valve

Eligible source countries of the products shall be Japan or Development Assistance Committee of OECD (DAC) member countries or the Hashemite Kingdom of Jordan.

Applicants for Prequalification of the tendering shall satisfy the following conditions.

- (1) to have the head office, branch offices, liaison offices or agents in the Hashemite Kingdom of Jordan by the date of contract.
- (2) Neither joint venture nor consortium is allowed.
- (3) to be in sound financial conditions. The applicants for prequalification shall submit financial statements for the last three (3) consecutive fiscal years comprising audited balance sheets and profits and loss statements.
- (4) to have experiences of trading in the Hashemite Kingdom of Jordan or trading in the Middle Eastern countries.
- (5) to be capable of providing after-sales service. The qualified firms or companies have to submit the Certificate of After-Sales Service at the time of tender.
- (6) to satisfy the numeral criteria (55 points or more). The total numerical figures are calculated based on the actual figures acquired for each of the items featured in QUALIFICATION TO PARTICIPATE IN TENDERING PROCEDURES attached herewith.

The trading firms or manufacturers of valves who are interested in supplying the products and incidental services should submit following documents in English to JICS on or before 17:00 Japan Standard Time (Jordanian standard time 11:00 am) on the 19th of February, 2013 by registered mail or courier.
